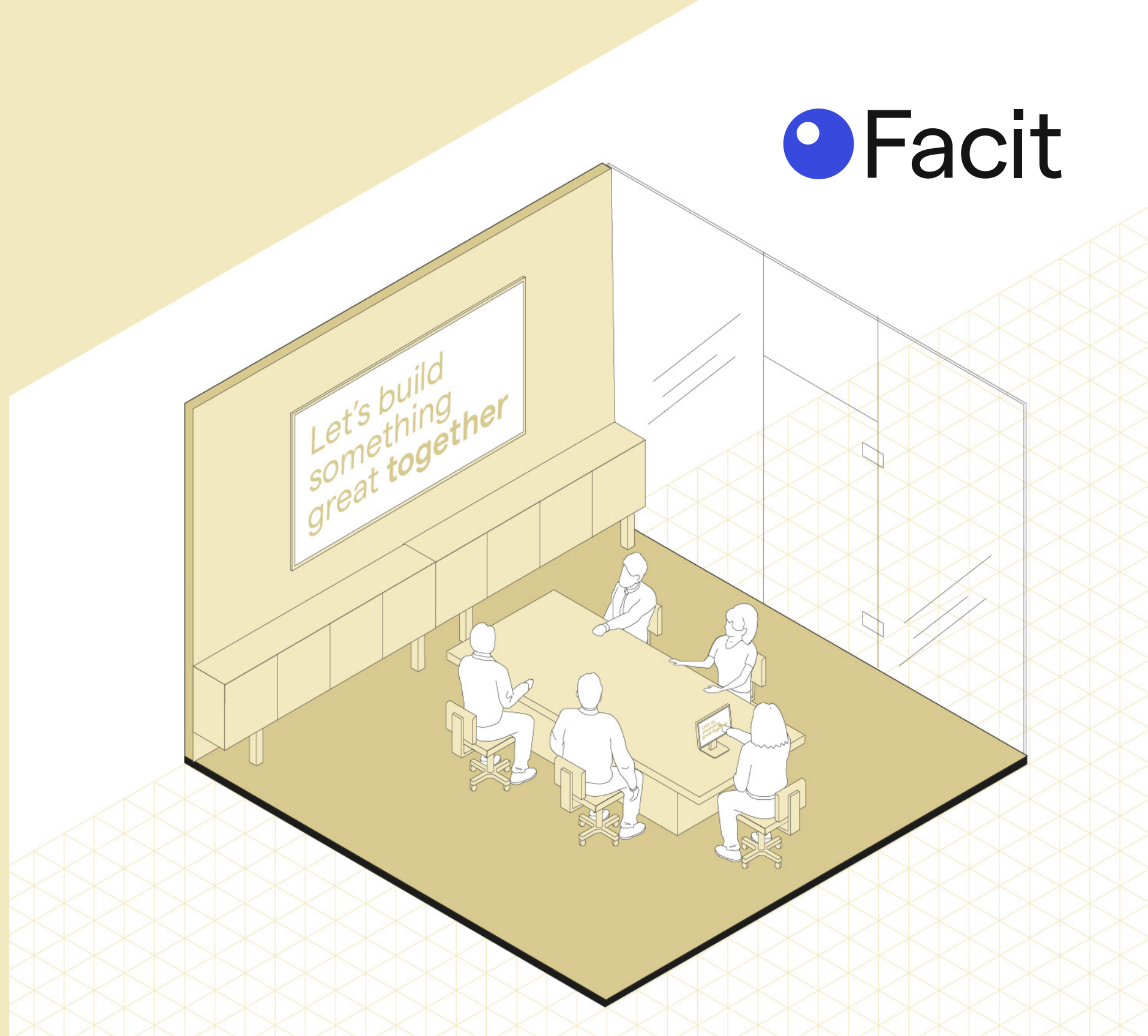

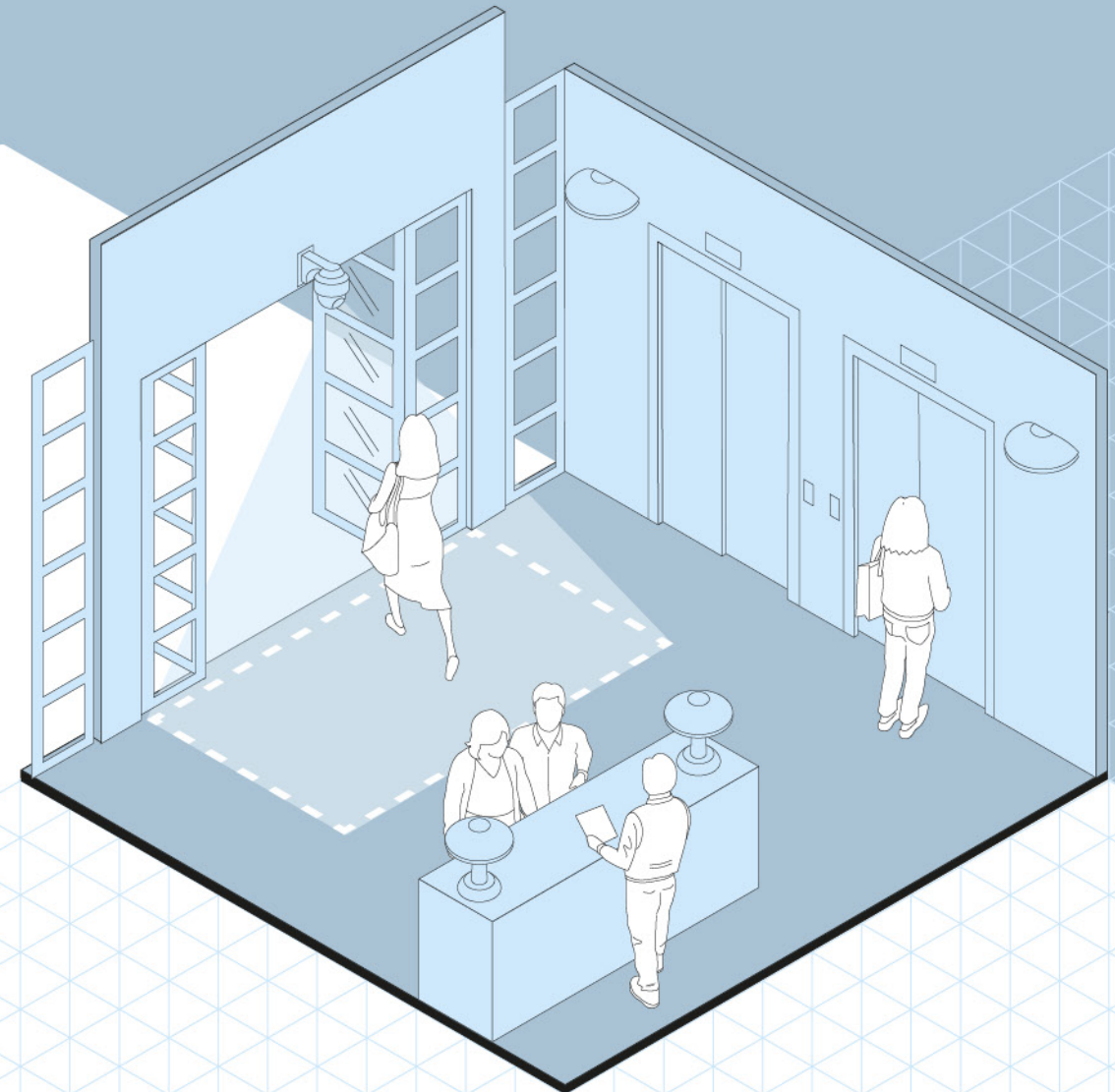

### Your own demo software and free trial for customers

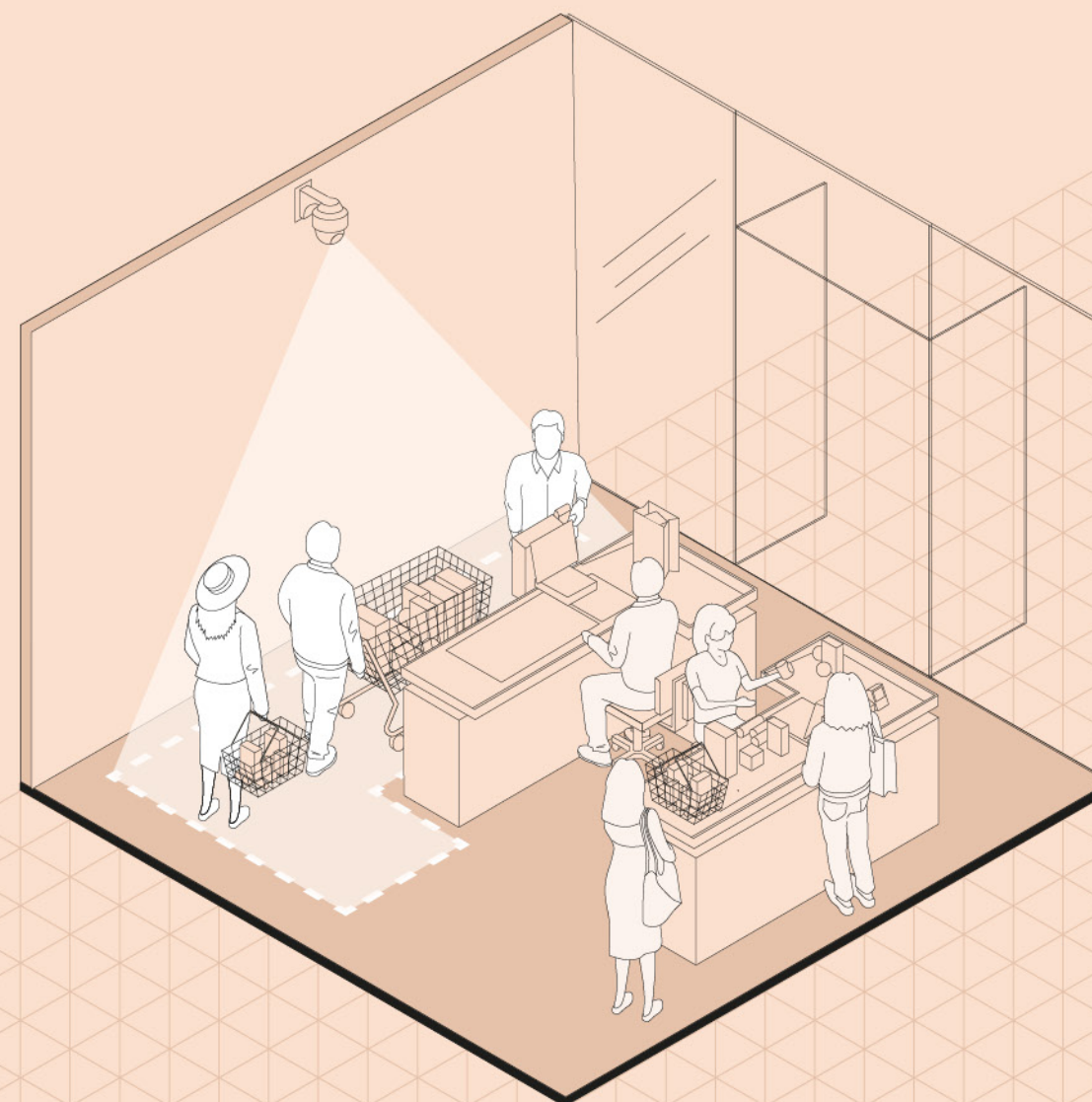

## Live blur

For live footage being monitored by operators, redact heads, bodies and licence plates across cameras in real-time.

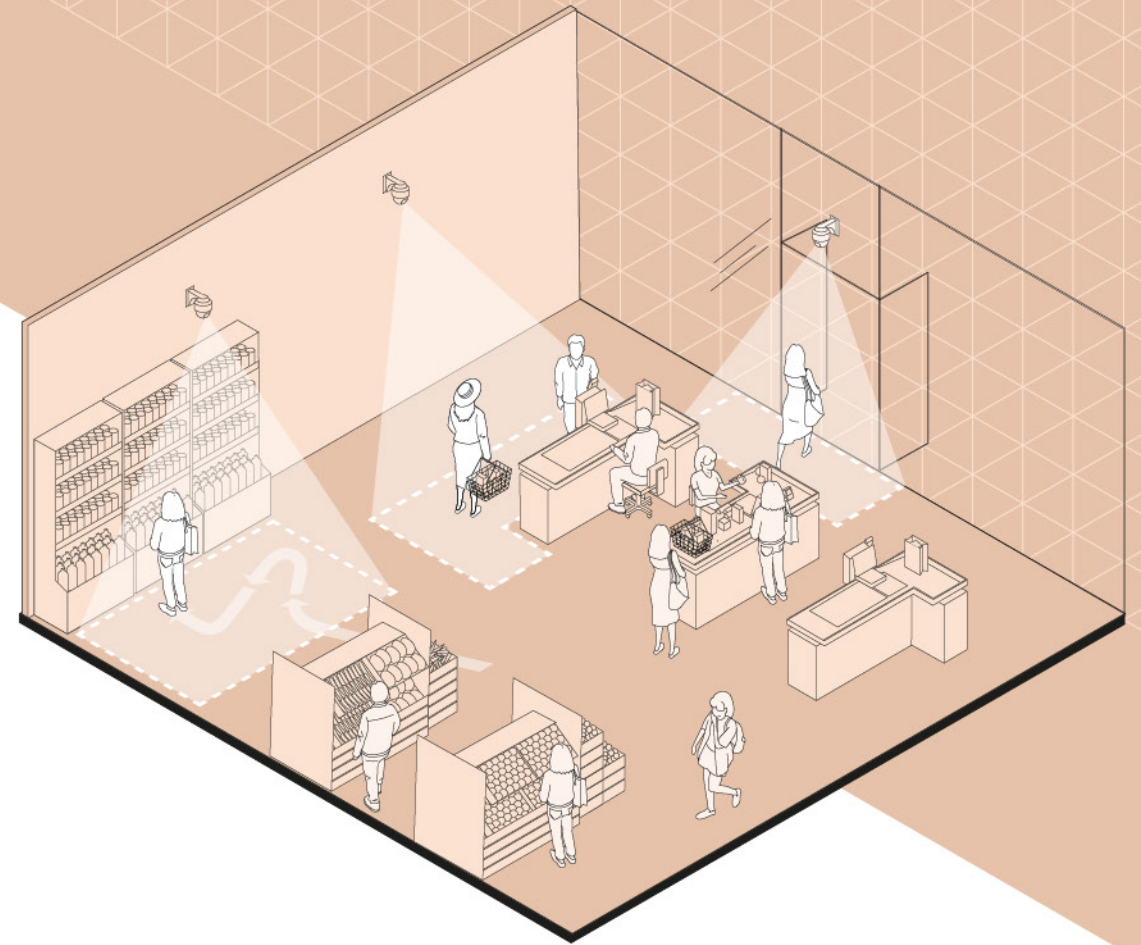
Redact videos within XProtect; direct from cameras, imports or screen record.

## Slip, trips and falls

## Smart Count

- Get live alerts for trolley pushouts

- Fixed cost for budget certainty and forecasting



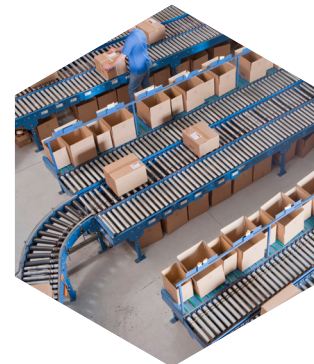
## Education
